INTERLOCUTORY

ORDER GRANTING PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT & FINAL JUDGMENT

On this day, came on for hearing and Final Judgment Plaintiff's Motion for Summary Judgment. The Court finds that all parties received timely notice of the hearing. Based on the summary-judgment evidence, the Court finds that Plaintiff's motion should be GRANTED.

The Court finds that Plaintiff NASA Federal Credit Union ("Plaintiff") ought to recover its damages from Defendant Rodrick Levingston ("Defendant"), and it appearing to the Court that after all offsets, payments, and credits have been allowed, Plaintiff has been damaged by Defendant in the sum of \$22,487.57.

IT IS, THEREFORE, ORDERED that Plaintiff do have and recover of and from Defendant judgment in the sum of \$22,487.57; pre-judgment interest at the statutory rate of 6.00% per annum from March 4, 2024, through entry of judgment, compounded annually post-judgment interest at the rate of 7.75% per annum from the date of judgment, together with a reasonable and necessary attorney's fee in the sum of \$6,029.50, with interest thereon at the rate of 7.75% per annum from date of judgment, and with its costs in this behalf expended and that it have its execution.

IT-IS FURTHER ORDERED, ADJUDGED AND DECREED that-in-the-event-Plaintiff prevails on any appeal in the Court of Appeals or by bill of review filed by Defendant, Plaintiff shall recover \$30,000.00 from Defendant.

IT-IS FURTHER ORDERED, ADJUDGED AND DECREED that in the event Plaintiff

prevails on petition for review to the Texas Supreme Court (by prevail meaning any petition for review by Defendant is denied or any petition by review by Sterling is granted and judgment of the trial court is affirmed), Plaintiff shall have and recover \$20,000.00 of and from Defendant.

IT-IS FURTHER_ORDERED, ADJUDGED AND DECREED that in the event Plaintiffprevails after any petition for review is granted by the Texas Supreme Court; Plaintiff shall recover \$15,000.00 from Defendant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all writs and processes, including any writ of execution, for the enforcement and collection of this judgment or the costs of court shall issue as necessary in favor of NASA-Federal Credit Union.

TT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Judgment finally______ disposes of all claims and all parties and is appealable.
